


IT IS HEREBY ORDERED AND ADJUDGED that:


1. The Board of Regents will pay to Dr. Laskar, through ordinary payroll procedures and no later than April 15, 2011, back wages accrued between and including May 18, 2010 and March 31, 2011, in a lump sum payment in the amount of \$181,161.29 (less withholding);
2. At the same time that it makes the back wages payment to Dr. Laskar required in paragraph 1, above, the Board of Regents will make its matching contribution (9.24% of salary) to Dr. Laskar's retirement account with TIAA-CREF in the amount of \$16,739.30;
3. Commencing on April 1, 2011, and on a going-forward basis unless and until the date of a final decision by the President of Georgia Institute of Technology to terminate Dr. Laskar's employment, made after the receipt from a duly appointed faculty committee of a recommended decision upon the conclusion of a hearing in accordance with Section 5.10.4 of the Georgia Institute of Technology Faculty Handbook, the Board of Regents will reinstitute Dr. Laskar on its payroll and will resume making ordinary salary payments to him and providing to him the full array of benefits (including, but not limited to matching retirement contributions) accorded to him as of May 18, 2010;
4. On or before April 15, 2011, the Board of Regents will pay to Dr. Laskar, care of his attorneys, Gaslowitz Frankel LLC, \$6,887.45 in pre-judgment interest;
5. On or before April 15, 2011, the Board of Regents will pay to Dr. Laskar, care of his attorneys, Gaslowitz Frankel LLC, \$53,451.33 on account of his attorneys' fees and costs incurred in relation to this action;
6. This case is dismissed with prejudice, except that this Court shall retain jurisdiction solely for purpose of enforcing the terms of this Consent Final Judgment.


